

#### Core Services Project Overview

- Public Health Act of 2008 standardized core services in Colorado
  - Established 7 Essential Core Services
- Project measured impact of the Act
- Examined service availability, LPHA structure, funding, FTE
- Similar to measures collected by NACCHO, MPROVE


Are the core service measures reliable and valid?

#### RELIABILITY

#### Reliability:

If we asked the same question in the exact same way under the exact same circumstances, would we get the same answer?

#### Test-Retest Reliability

- Fills in survey/test at time A
- Allow for enough time to pass to forget how it was filled out but not enough time that the situation has changed
- Fills in survey/test at time B
- Compare results to see if there are significant differences

#### Test-retest methods

- Selected 19 Agencies
- Agency filled out selected measures 2-4 weeks after initial survey
- Selected measures across different domains

# Reliability Methods

#### Standard Approaches:

- Percent Agreement
  - Higher is better, possible range: 0-100
- Kappa: Compare how we did versus random chance
  - Possible range:
    - I (perfect) 0 (random) –I (bad)
  - Higher is better

# Interpreting Kappa

< 0

Less than chance agreement

0.01 - 0.20

Slight agreement

0.21 - 0.40

Fair agreement

0.41 - 0.60

Moderate agreement

0.61 - 0.80

Substantial agreement

0.81 - 0.99

Almost perfect agreement

### Reliability: Methods II

- Weighted Kappa
  - For multiple categories
  - Answers further off are weighted more heavily than answers that are relatively close

### ° VALIDITY

#### **Validity**

- Truthfulness: Does the test measure what it purports to measure? The extent to which certain inferences can be made from test scores or other measurement. (Mehrens and Lehman, 1987)
- The degree to which they accomplish the purpose for which they are being used. (Worthen et al., 1993)

# Construct Validity Methods

- Located similar measures in NACCHO profile
  - 47 total measures identified
- Measures included:
  - personnel employed
  - revenue/expenditures
  - surveillance, screening, inspections
  - direct services
  - prevention activities
- Correlated
  - Kappa

### Validity Summary

- High concordance on measures about the LPHA itself
  - Funding
  - Services
  - Inspections
- Lower concordance on measures about what happens elsewhere in community
  - Not done
  - Done by someone else

#### Conclusions

- Reliability and validity high for measures asking about structure, funding, services provided by LPHA
- Reliability concerns about questions about capacity or projections
- Validity concerns about measures asking about services provided elsewhere in community
